

Terms of Service

The Terms of Service (the "ToS") is a binding contract between you, an individual user ("you") and eat-live-sleep.com Ltd, company number 09000924 incorporated in England and Wales . ("ELS", "us" or "we") governing your use of the ELS website (the "Website" or the "Service"). BY ACCESSING OR USING THE SERVICE, YOU AGREE THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE BOUND BY THE ToS IF YOU DO NOT AGREE, THEN YOU MAY NOT USE THE SERVICE.

- o Clients.
 - Fees. The fee (the "Fee") to be charged to Clients for each Design Package will be set forth on the Service The Fee is due and payable in advance of Client's initiation of a Project.
 - Payments. The Service currently uses third parties to process payments Our third-party payment processors accept payments through various credit cards, as detailed on the applicable payment screen All monetary transactions on the Service take place in British Pounds.
 - <u>VAT</u> All prices published on the website are exclusive of VAT.
 - <u>Taxes</u> are responsible for determining and paying any other appropriate government taxes, fees, and service charges resulting from a transaction occurring through the Service, except for taxes on ELS's income We are not responsible for collecting, reporting, paying, or remitting to you any such taxes, fees, or service charges, except as may otherwise be required by law.
 - Refunds The Service will offer any Client a full refund for a Design Package before the Client approves a design. In order to process a refund, we will require the Client to speak with us via phone about the designs the Client received.
- Your Use of the Service and Service Content.
